- Assist in the sourcing and development of teaching and learning materials;

- Attend meetings and development sessions, as required;
- Provide administrative support;
- Monitor and manage the communal behaviour of students during break and lunch times;
- Support with the enactment of school policies;
- Be available on campus within term time between the hours of 07:30 and 15:30.

Professional Expectations:

The Library Teacher Assistant will:

- Have excellent communication and interpersonal skills;
- Be conscientious, efficient and organised;
- Be keen to learn;
- Be a native user of the Chinese language;
- Demonstrate a good level of spoken and written English.
